SITUATION IN FRANCE IN 2022

The situation in the France is not very bright, economically, financially or socially.

1) As a reminder, the Official Public Debt is around -€3,000 billion.

Its GDP is about €2,500 billion.

On the other hand, the Real Public Debt (Official and Hidden) amounts to about -7,500

.....

2) The Public Deficit will exceed -175 billion € in 2022.

3) The Trade Deficit has itself been in total drift since 1999.



The cumulative deficit since the adoption of the euro was -€1,000 billion in current euros. It had been in deficit of only -€64.4 billion (equivalents) over the period 1971-1998. For 2021 alone: it was -€ 84.7 billion (but in reality -€102.9 billion according to EUROSTAT). For the year 2022, it will happily exceed -€150 billion.

4) Job losses in Agriculture and Manufacturing are enormous.

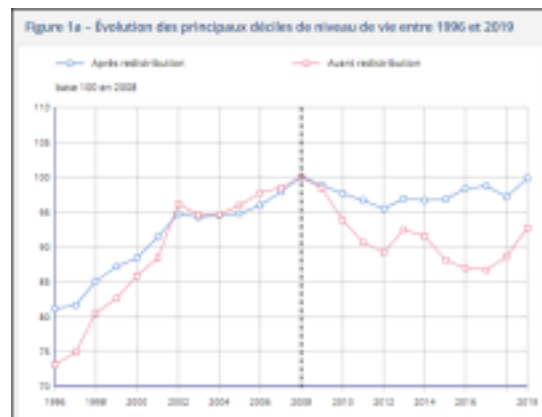
In the most "realistic" scenario, we have therefore lost more than 4,000,000 agricultural and industrial jobs since the creation of the euro (²), double that if we count the economic benefits in families and regions.

However, for the record, the population of the France has increased by 10,000,000 inhabitants in 30 years.

Still for the record, many productions are at a standstill in a large number of economic sectors.

And many products are missing from the shelves because of wild subcontracting .

5) Poverty in France: INSEE 2019 (<https://www.insee.fr/fr/statistiques/5431993>) I let you discover their comments but, one thing is clear, the statement of Fabien ROUSSEL (PCF) is verified on this graph:



"The left must defend work and not be the left of social benefits and minima."

And I add :

"The left must not be the left of torturer officials ."

² This type of study is not readily available, but TRANSRURAL reported that 1,500,000 active people remained in 1992, while the latest figures show 400,000 active people at the end of 2020. An INSEE study, published for the period 1982 – 2011, already estimated job losses at -1,071. 400 in Agriculture and - 1,556,400 in Manufacturing. The phenomenon has grown since 2011.

Yes, I denounce these administrations which, directly or indirectly, "monitor" and "enslave" more than a third of the population (³).

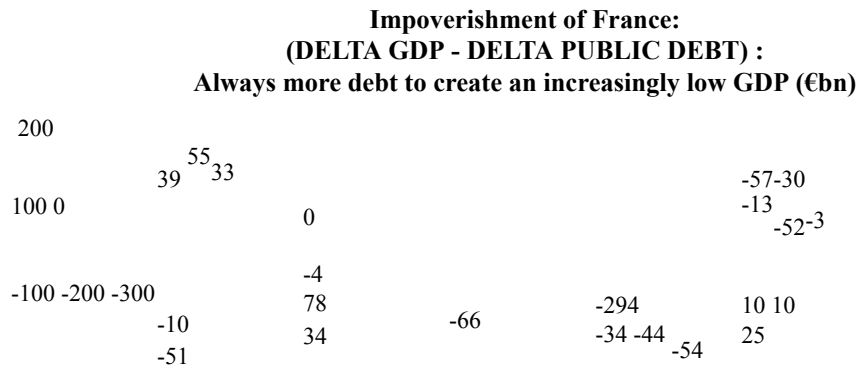
On the other hand, how do they manage such an unmanageable country?
