I. EXCERPTS FROM Mrs von der LEYEN'S SPEECH (Comments in red)



"For the first time in its history, this Parliament is debating the state of our Union as war rages on European soil.

We all remember that fateful morning at the end of February.

All over our Union, Europeans woke up, overwhelmed by the weight of the news coming from Ukraine.

Shaken by the return of an implacable Evil.

Haunted by the sound of sirens and the brutality of war.

But from that moment on, the entire continent stood up in a wave of solidarity.

 - combating fraud of all kinds.

In short, priorities are exactly what you do not do.

They adopted the "great ultra-liberal values" of the International Labour Organization (and its definition of "unemployment") before inventing all sorts of social traps to avoid identifying a mass of increasingly precarious people.

Yes, these statistics are manipulated

but that does not prevent you from citing them as a performance.

Our needs for rare earths alone will increase fivefold by 2030.

And that's a good sign!

II. TRUE “STATE OF THE UNION”: THE FACTS.

Faced with such a Manichean presentation of the European Project by Mrs von der LEYEN, it seemed urgent to me not only to denounce her speech by putting my comments (in red) but also to remind her of certain truths about the Maastricht Treaty and the dysfunctions of Political Europe before drawing the necessary conclusions.

QUESTIONS?

- Who will endorse this project? On what criteria?
- When will parliamentary debates take place?
- At european level and at the level of nations?
(Answer: never).
- By the way, who will benefit?

What if this change of currency prepared for the break-up of the euro zone?

am at the disposal of the European peoples to «dig» all these questions (and avoid them the worst)!

But I immediately warn the whole European Left, the Greens and the parties of the Ultra-Left: you will pay dearly for the fruitless debates that you constantly impose on us...

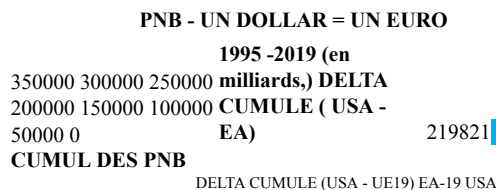

2) The long-term comparison of the GDPs of the Eurozone (EU-19, reconstituted since 1994, just after the Maastricht Treaty) and the United States is simply astounding.

This work was represented by a graph in the book mentioned :

Figure 25: Abandonment of any Strategy: Impact on CUMULATIVE GNP 1995 – 2019 (€MD)



• In 1994, the GDP of the United States was of the same order as ours: \$7,640 billion against \$5,742 billion

(USA/EU-19 = +33%).

- To avoid biasing these official statistics (World Bank in dollars and Eurostat in euros), I kept the rate of ONE DOLLAR = ONE EURO.
- On this Graph 25, the sums of cumulative GNP 1995 – 2019 are of course colossal: 219,821 billion euro for the EU-19 against 348,506 billion dollar for the USA (USA/EU 19= +58.5%).

Clearly, we have done "much worse" than the United States, which is in a phase of regression because of all its budgetary, trade and payment deficits.

3) Since September 2022, Christine LAGARDE's ECB has adopted VOLCKER's monetary policy by openly displaying a total contempt for the people.

However, no one in "honest" economic circles that the choice of VOLCKER led to the destruction of the American economy, the most successful economy in the World before the 1980s, by annihilating the entire domestic fabric.

TRUMP did not come to power by accident, and the fight of the far right is not over in the United States. Some media and politics even mention the risk of a civil war.

Indeed, everyone knows that this policy leads to the enrichment of banks and the multiplication of company bankruptcies, with colossal losses of jobs and income (wages, pensions). *"Regaining and maintaining confidence requires us to quickly bring inflation back to our target,"* said Isabel Schnabel – ECB – Germany.

"Even if we enter a recession, we simply have little choice but to maintain the direction of our policy," she added.

"If inflation expectations were to become unsettled, the impact on the economy would be even worse."

Meanwhile, Christine LAGARDE multiplies her disguised aid to High Finance by exceeding her powers: it is now the ESCB (led by the ECB and the BIS) which «makes politics» in Europe.

Trap for inconsequential political parties, they let it happen and, better, they applaud its initiatives: fight against the pandemic (no, the ECB did nothing); fight against climate change (ECB-wide climate agenda: who appropriated it?); green bonds (who benefits?); support for OTC markets (SESFOD: who understood?); support for Ukraine (so little); fight against the risk of splitting up the eurozone (who can believe it?); fight against inflation (who thought of the disaster to come?), etc.

In fact, the Central Banks of the 63 BIS participants have "lost control" of the consequences of their "conventional and unconventional policies".

And no one's reporting them!

No one condemns them!

While we must forbid them all to continue their game of dirty kids!

B. POLITICAL EUROPE

Politically, the European Union is highly open to criticism.

1) Europe is not "protective".

It only takes a "small" threat of invasion by Russia to realize that we depend entirely on the U.S. military to defend ourselves.

This "assistance" has a cost: the Americans supply their weapons to virtually all European countries, including Switzerland. And these are not gifts but loans!

This "indispensable assistance" is also the result of a sneaky policy of NATO and High Finance who want to conquer the world from West to East, from North to South, from ocean to ocean, even if it means enriching our worst potential enemies: China, Russia, Turkey, Saudi Arabia and

the fiercest dictatorships in the World.

2) Germany is

highly responsible for this situation.

It has used the "single market" and eastern enlargement policies to source agricultural materials, industrial raw materials, slave labour and cheap labour (immigration) to destroy a whole bunch of vital economic sectors among its most reliable partners.

Even the German population suffers because, as you can see, their food is not healthy (too much pork, sausage and starchy foods) and the quality of everyday goods has been taken in hand by the big brands of the German Hard Discount, with questionable quality products.

3) The European Union has fostered a Europe of thieves.

Luxembourg, the Netherlands, Ireland and Flanders have built legal and tax systems that deprive other partners of their tax revenues.

Better, Ireland has taken over the Anglo-Norman type of Closed Holdings system to allow insurance groups to steal our savings (supplementary pensions, life insurance).

It also allows American groups to hide their financial assets and profits with impunity.

4) The European Union has even missed all the technological shifts.

The services sector (other than bancassurance and the distribution of mainly imported products) is now dominated by Americans: software, networks (including transoceanic wiring and satellites), space (rockets, space projects), pharmaceutical innovations, innovations in remote care and surgery equipment, advanced electronic equipment, defense, cybernetics, ...

The list of our weaknesses is sickening.

5) The European Union and the European countries have become the benchmarks of senior careerist officials.

These senior officials are there to concentrate our material wealth, our heritage wealth and our financial heritages in the hands of increasingly powerful actors, acting legally outside the nations and the European Union itself.

Their powers consist of a "laissez-faire" policy that allows transnational corporations and high finance to "play politics" instead of political parties, parliaments and people's choices. And of course, they serve themselves... instead of serving (the people).

6) At a time of "austerity policies", the ECB announces its own political choices.

It will "encourage" various policies by buying shares and bonds of private companies: it is it that chooses its interventions, without any debate, without any consultation but, as RECLAIM FINANCE points out, with its "Green Central Bank Scoreboard of the G20", all these operations are **Greenwashing**.

Better still, it is a strategy of enslavement of populations: ever more public debts, ever more profits, ever fewer rights for the populations.

We all thought that Angela Merckel's Germany would be criticized within the European Union, and especially by her successors, for its

compromises with Putin's Russia, with Erdogan's Turkey, with RBS's Saudi Arabia or with China's murderous regime.

Olaf SCHOLTZ wants even more openness to the East, to Georgia, and he wants to build the largest army in Europe.
